



## Invitation to LiTeum TDE

**LiTeum is a project of iDiTech s.r.o.**, a limited liability company (in Czech: společnost s ručením omezeným) incorporated and existing under the Laws of the Czech Republic, with its registered seat at Prague, Na Folimance 2155/15, Prague 2 – Vinohrady, Postal Code 12000, Czech Republic, Identification No.: 05459401, registered in the Commercial Register maintained by the Municipal Court in Prague under File No. C 263971 (the “**Company**”)

HEREBY INVITES EVERYONE WHO (A) WANTS TO PARTICIPATE IN TOKEN DISTRIBUTION EVENT OF LiTeum PLATFORM AND (B) IS NOT A RESTRICTED PERSON (AS IS DEFINED BELOW) (“**RECIPIENT**”)
